INFORMATION BY STATE'S ATTORNEY

By the authority of the State of Vermont, the State's Attorney for Orange County, upon the oath of office charges:

COUNT 1 OF 1


CHARGE CODE: 13V3253A9, CHARGE NAME: Sexual Assault-Agg-Repeated, OFFENSE CLASS: F

Michael S. Jacques, in this Territorial Unit, in the County of Orange, at Randolph, between October, 2003 and June, 2008, engaged in a sexual act with another person and compelled the other person to participate in a sexual act, to wit, contact between the penis of Michael Jacques and the vulva of [REDACTED], dob: 10/[REDACTED]/1993, without the consent of the other person and the victim was subjected by Michael S. Jacques to repeated nonconsensual sexual acts as part of the same occurrence or the victim was subjected to repeated nonconsensual sexual acts as part of Michael S. Jacques's common scheme and plan, in violation of 13 V.S.A. §3253(a)(9).

Penalty: imprisoned not more than life or fined not more than \$50,000.00 or both.

AFFIDAVIT

STATE OF VERMONT

NOW COMES Detective Sergeant William M. Jenkins, affiant(s), being duly sworn and on oath, deposes and says he has probable cause to believe that Michael S. Jacques DOB 03-18-1966 has committed the offense(s) of Aggravated Sexual Assault, a violation of 13, Vermont Statutes Annotated Section 3253.

The undersigned being duly sworn, deposes and says that I, Det. Sgt. William M. Jenkins am now and have been for the past 14 years and 4 months, a full time employee of the Vermont State Police, being presently assigned to the Rockingham Station as a Detective

On 06-25-2008, the Vermont State Police in Royalton began an investigation into the disappearance of a 12 year year old female. During the course of the investigation, [REDACTED] (dob 10-[REDACTED]-1993) was identified as a witness.

On 06-29-2008, at approximately 14:20 hours, Det. Sgt. William Jenkins conducted an interview with [REDACTED] at the State Police Station in Royalton. [REDACTED] [REDACTED] was present. [REDACTED] advised of the following during the interview:

When [REDACTED] was approximately nine years old she got a phone call and a note under her pillow that said that she was in a program for sex called Breckenridge. People from Breckenridge choose to put you in the program. She and her mother were in Wal-Mart and a guy had followed her around and thought she should be put in the program. The president gives you a trainer but you don't get to talk to the president. [REDACTED] Michael Jacques, was to be her trainer.

[REDACTED] explained that you have to do "things" for the program. She was enrolled with three other girls. The first who does it lives and the second gets her throat cut. They would kill [REDACTED] mother because she was on a business trip.

[REDACTED] did not really do anything when she was younger. Most girls get out of the program when they are twelve but she is still in the program because she did do these things. [REDACTED] expressed for some reason she was not killed and did not know how she was alive. The Breckenridge program had been a part of her life since she could remember.

[REDACTED] thought she was nine or ten years old when she did her first act with Jacques. This first act she thought was a "blowjob" that happened at her old house. Jacques ejaculated. The frequency of the sexual encounters with Jacques was weekly but they varied. The last time was

" weeks ago, maybe June (2008)." She further explained that the sexual encounters with Jacques included vaginal intercourse, anal intercourse, oral sex on her and oral sex on him.

One time, Jacques tied her up because the program told him he had to. The program wanted her to know what it is like. He tied her wrists over her head to the futon in the computer room.

She further explained the Breckenrdige program. In order to graduate, you had to attain 75% on how you perform. She is now at 50% and the men tell you what to work on. She would receive phone calls and e-mails from Breckenridge. These correspondance would tell her what sexual acts to perform. She stated she has met three men from the program and one of them she identified as Jacques.

[REDACTED] Denise and Michael have been living at their current home, 1820 E. Bethel Road, in Randolph for approximately five years. Their prior residence was next door.

She recalled a time when she came home early from work to find Jacques coming down the stairs. She went upstairs and [REDACTED] was around Denise's bedroom wrapped only in a towel. She asked [REDACTED] what she was doing and [REDACTED] said she was taking a shower. Denise said the shower was dry, she found a pornographic DVD and KY jelly in her and Michael's bedroom. She explained that she and her husband were not using KY jelly for their sexual relationship at that time.

Denise advised that one time she had found male and female child pornography on their home computer and that the children were around [REDACTED] age. She questioned Jacques and he told her did not know how it got there.

Denise recalled locating a dildo in [REDACTED] room and [REDACTED] told her she was holding it for a friend.

A criminal history check on Jacques revealed that he had been convicted of Kidnapping and Aggravated Sexual Assault in Orange County Vermont in 1993.

On 06-29-08, at approximately 16:15 hours, Jacques was taken into custody.

Based on the above, I have probable cause to believe that Michael Jacque's has committed Aggravated Sexual Assault.
